### **A RESOLUTION OF THE BOARD OF COMMISSIONERS OF KITSAP COUNTY FIRE DISTRICT #18 TO AWARD A RESCUE EQUIPMENT PURCHASE CONTRACT TO A SINGLE SOURCE SUPPLIER**


#### **RESOLUTION NUMBER 21-10**


- WHEREAS: It has been determined that KCFD #18 (District) needs to replace rescue equipment capable of cutting and disassembling late model year cars and trucks that contain (UHSS) Ultra-High-Strength-Steel and metal alloys; and
- WHEREAS: Holmatro is the current rescue equipment that the district operates; and
- WHEREAS: The district wishes to continue to utilize the existing Holmatro rescue equipment and provide interoperability as well as redundancy in case of equipment failure at the scene of an emergency; and
- WHEREAS: Continuing to utilize Holmatro brand rescue equipment will enable the district to maintain standardization of equipment maintenance and training; and
- WHEREAS: It has been determined that West Coast Fire and Rescue is the only authorized vendor for Holmatro rescue equipment in the Pacific Northwest;
- THEREFORE,  
BE IT RESOLVED:
1. That for the reasons listed above, the district hereby waives the formal bid law requirements in awarding the contract herein before outlined, pursuant to the provisions of RCW 39.04.280 which allows formal bid requirements to be waived where the requested service and/or material is/are limited to a sole supplier; and
  2. The Fire Chief or designee is hereby empowered, on behalf of the district, to purchase equipment from West Coast Fire and Rescue in the estimated sum of \$42,300 (including sales tax) which has been determined to be a reasonable sum.
